ANNOUNCEMENT AND INVITATION TO THE AUTHORS

We are very pleased to announce that the Republic of Srpska's Ministry of Traffic and Communications and the Republic of Srpska's Traffic Safety Agency will organise this year the III Scientific Conference under the title "Local Community Road Safety", which will be held on the 30 and 31 October 2014 in Banja Luka.

We would like to use this opportunity to invite you to take an active part in the work of the Conference by transferring your precious experiences from the field of road safety in local communities.

AIM OF THE SCIENTIFIC CONFERENCE:

In the organisation of the Republic of Srpska's Ministry of Traffic and Communications and the Republic of Srpska's Traffic Safety Agency, two seminars were held over the past two years in Banja Luka on the topic of the road safety in local communities.

The Republic of Srpska Government adopted the "Road Safety Programme in Republic of Srpska for the period from 2014 – 2018" in February 2014. By adopting the programme, as well as the previous "Road Safety Strategy for 2013 -2022" important assumptions were created aimed at road safety management and, consequently, the reduction of the number of traffic accidents and the number of casualties on the Republic of Srpska's roads. In order to realise this, we need the support of the society as a whole, as well as the readiness of all road safety stakeholders for a joint action towards the implementation of the Programme.

From the conclusions adopted following the previous seminar, it is necessary to underline the obligation of the Traffic Safety Agency to establish, in collaboration with other stakeholders, a process of continuous development of traffic safety professionals, initiating and following the regulations by which the stakeholders are obliged to undertake continuing professional development in order to achieve a better performance of assigned tasks.

In addition to the continuing professional development and increasing readiness for performance of assigned tasks, the III International Conference "Local Community Road Safety – 2014" is aimed at assisting all road safety stakeholders, and in particular the local self-government units, in recognising their role in road safety improvement.
